Communications/Announcements/Reports

Kim Carlock, Town Clerk stated that the following Departments have filed their reports and they are on file in the Clerk's Office: Receiver of Taxes, Water and Sewer, bldg. and the Police Department.

Councilor DiMartino announce that the Memorial Day Parade will be held Saturday on May 28th at 10:00am departing from the East Greenbush Bowling Center on Columbia Turnpike, and ending at the VFW on Hays Rd. She also stated that the Community and Recreation Department were putting on the Town wide garage sale on June 4th, and that they were seeking vendors for a small fee of \$25.00 for the East Greenbush Town Festival on August 20th 2016.

Councilor Matters announced that Good Buy Books on Columbia Turnpike was celebrating their tenth anniversary in business and to stop by and wish them well. She also commented on the businesses along Columbia Turnpike that have enhanced there façades. She explained how wonderful they looked and wished more businesses would do the same. Councilor Matters also congratulated Tim Boel on his retirement and wished him well in the future.

Councilor Grant also stated that the Library will be starting their summer book club soon, and that the Farmer's Market would be opening outside of the Library every Wednesday starting June 15th. He also stated that he wanted to congratulate and wish Tim Boel well.

Councilor Tierney stated that the East Greenbush School District passed this year. She stated that she was at a meeting at the School and they explained that the number of children in the school district living below the poverty line did go up slightly this year. She felt that this was an unfortunate statistic to see rise. They also announced that they are looking for Bus Drivers for the School Year. Councilor Tierney also wanted to thank the Emergency responders who responded to the deck collapse. She stated that it was a well handled situation that could have been worse.

Supervisor Conway stated that the Board of Ethics has submitted a revision to the Ethics Code. He thanked Kathy Luria and the Board of Ethics for the time that they put into this. You will be hearing about a meeting and a public hearing soon.

The Board thanks everyone in attendance for their understanding and also for their desire to actively participate in the decision making process locally. Tom Gullo- He wanted to inform the Board of a situation on Phillips Road with Dump Trucks running 24/7. He contacted Rensselaer County and found out that they have a clean fill permit. He was told that they got around the 10 ton law because it is a local delivery. His problem is with them coming in all hours of the night, and worries about the road with all of that travel with the heavy trucks. Tom wanted to know how to get the local delivery law changed to more reasonable hours.

Supervisor Conway stated that they will look into it.

Jim Walsh- spoke regarding the paving resolution. He explained that the Town needs to maintain a standard for the Town Roads. The milling process is something that every company does not do. He believes in this company and stated that we do not have time to waste, and that we have to move forward with this resolution.

There was an extensive discussion between the Board Members and Mr. Walsh regarding this topic.

A Resident thanked the Board and Tony Manfreddi for the presentation of developing 9 & 20 at the pre Board meeting. She had some questions and concerns for the Regeneron project.

Pete Stenson-thanked the Town for putting the AUD on line. Pete spoke regarding mitigation fees and intra-fund borrowing.

Hal Betters-made comments on the 9 & 20 presentation. He mentioned planting plants ofr flowers in front of the WWTC, and explained that he does not feel that 9 & 20 is condusive to sidewalks.

100-2016 A Resolution Supporting Passage of New York State Assembly Bill A9831

WHEREAS, the NY State Assembly has introduced Bill A9831 "An act to amend the public authorities law and the environmental conservation law, in relation to the construction of a pipeline property under the control of the New York State Thruway Authority"; and

WHEREAS, this legislation would prohibit a pipeline on the NYS Thruway designed to carry hazardous materials including but not limited to petroleum; and

WHEREAS, the East Greenbush Town Board passed Resolution 81-2016 "A Resolution Opposing the Pilgrim Pipeline Project"; and

WHEREAS, the proposed pipeline route through East Greenbush does not run within the NYS Thruway Right of Way but would be routed near cultivated fields in the Town; and

WHEREAS, the proposed IPT Product Lateral in East Greenbush would be adjacent to the northernmost boundary of the Papscanee Island County Nature Preserve and the pipeline would have a significant negative impact on the Preserve; and

WHEREAS, the proposed pipeline route in East Greenbush would require horizontal drilling under the Hudson River twice; and

WHEREAS, the proposed Pilgrim pipeline project potentially threatens the environment, health, safety, and welfare of the community; negatively impacts the cultivated fields near the route; decreases the values of homes located along its route and in surrounding neighborhoods; and negatively impacts potential future development in East Greenbush; and

WHEREAS, the Town Comptroller believes at this time that this resolution will not have a negative impact on the Town's finances;

This amount is the accumulative balance of the 2015 Consolidated Local Street and Highway Improvement Program (CHIPS) funding (\$3,150), the 2016 CHIPS funding (\$131,212), the PAVE-NY supplemental funding (\$29,933), Generic Environmental Impact Statement (GEIS) fees (\$69,700) and the paving budget for 2016 (\$20,000); and
