**225-2023 A Resolution Proclaiming October 2023 as Bullying Prevention Month in the Town of East Greenbush**

**WHEREAS**, children who witness bullying often feel less secure, more fearful, and intimidated; and

**WHEREAS**, bullying prevention activities in October include #BlueUp, Make

Friends with Someone You Don't Know and Challenge Others to Be Kind, Stand Up for Others, and Start Conversations: Change the Culture;

**226-2023 A Resolution Recognizing November, 2023 as “Adoption Awareness Month” and November 18, 2023 as “Adoption Awareness Day”**

**WHEREAS**, each year November is recognized as National Adoption Awareness Month. While all adoption-related issues are important, National Adoption Month is about spreading awareness. It is a month to encourage others to learn about adoption, and to acknowledge the people in this country whose lives have been impacted by adoption. The mission of National Adoption Month is to celebrate the families who have grown through adoption, and to recognize the many children who are still waiting for forever families; and

**WHEREAS**, in the United States, the first major adoption related effort occurred in 1976 in the state of Massachusetts. Then Governor Michael Dukakis proclaimed the first week of November “Adoption Week”, to promote the need for more adoptive families to care for the large number of children in the foster care system. In 1984 President Ronald Regan made Adoption Week a national event; and

**WHEREAS**, by 1995 the week had become so widely recognized there were too many events to fit into seven days so President Bill Clinton extended the week-long event into National Adoption Awareness Month, which is what we celebrate today; and

**WHEREAS**, National Adoption Awareness Day also occurs during National Adoption Awareness Month. Typically held on a Saturday, National Adoption Awareness Day is observed across the country in court hearings where thousands of adoptions are finalized simultaneously; and

**WHEREAS**, there are an estimated 114,000 children in the United States still waiting in foster care for an adoptive family; and

**WHEREAS**, the average wait is 3 years for a child in foster care to be adopted; now, therefore, be it

**RESOLVED**, that the Town Board declares November to be Adoption Awareness Month and November 18, 2023 to be Adoption Awareness Day.

**237-2023 A Resolution Authorizing the Town Supervisor to Enter into a Contract with Adirondack Mountain Engineering, P.C. to Provide an Audit of the Wastewater Treatment Plant [WWTP] Operations and Monthly Reports**

**WHEREAS**, Adirondack Mountain Engineering specializes in wastewater operations and has a Licensed 4A Operator on staff who will assist in performing an audit and review of treatment plant operations and monthly reports; and

**WHEREAS**, recent employee transitions have raised concerns and potential maintenance issues within the plant and Adirondack Mountain Engineering will assist with the review and bid specification creation to fix any problem uncovered in the review; and

**WHEREAS**, Adirondack Mountain Engineering is a Town Designated Engineer and based on their fee schedule, the quote for services is \$15,000; and

**WHEREAS**, the Town Comptroller confirms that this resolution will have a material financial impact yet to be determined and charged to account 81304.07; now, therefore, be it

**241-2023      A Resolution Authorizing the Town Supervisor to Sign Change Order #1 with Greenman-Pedersen, Inc. in Connection with the Tempel Lane Extension Project**

**WHEREAS**, this resolution was not able to be submitted in time to be considered at the regularly scheduled pre-board meeting of October 11, 2023 and was subsequently presented to the Town Board on October 18, 2023; and

**WHEREAS**, on November 27, 2019, the Town issued RFP 19-10 seeking consultant services for the Tempel Lane Extension Project: Utility, Roadway Design, Bid Support, and Construction Inspection, which will advance this portion of the Program; and

**WHEREAS**, Greenman-Pedersen, Inc. (GPI), selected pursuant to RFP 19-10 and Town Board Resolution 49-2020, is providing the Town engineering and other services, including bid support, for the Tempel Lane Extension Roadway Project; and

**WHEREAS**, in accordance with the Town Board’s Amended SEQRA Statement of Findings for development of the Regeneron Pharmaceuticals, Inc. (“Regeneron”) Tempel Lane Campus development and the Development Agreement between the Town of East Greenbush (“Town”) and Regeneron, the Town is constructing certain roadway improvements that are required as part of Regeneron’s Tempel Lane Campus development; and

**WHEREAS**, the Amended SEQRA Statement of Findings issued in November of 2018 by the Town Board as lead agency addressed both the Regeneron Tempel Lane Campus and the Tempel Lane Extension Project; and

**WHEREAS**, on December 15, 2021 (Resolution 317-2021) the Town Board adopted a negative declaration for the Tempel Lane Extension Project, finding that the proposed Tempel Lane Extension Project is consistent with the above-referenced Amended SEQRA Statement of Findings, and that no Supplemental Environmental Impact Statement is necessary because the Project remains within the impact thresholds and mitigation established in the Amended SEQRA Statement of Findings; and

**WHEREAS**, Regeneron has consulted with the Town regarding the proposed addition of a 3,800 linear foot pull-off area to be constructed along Tempel Lane Extension at the expense of Regeneron; and

**WHEREAS**, in response to said proposal, the Town has instructed GPI to complete a Change Order Request and a set of plans, which are attached hereto, for the inclusion of the proposed addition of 3,800 linear feet of new roadway and the widening of 1,600 linear feet of existing improvements; and

**WHEREAS**, GPI, in the Change Order Request attached hereto, has determined the additional cost for the proposed improvement to be in the amount of \$35,480.50; and

**WHEREAS**, GPI, in the letter attached hereto, has determined that the work requested will be completed in areas which have been previously disturbed and that no work performed will affect environmental restrictive or protected areas; and

**WHEREAS**, the proposed addition is within the scope of disturbance covered by the above referenced negative declaration and SEQRA Statement of Findings; and

**WHEREAS**, there is sufficient contingency in funds received from Regeneron Escrow account (51124.03.004.104) for the amount of \$35,480.50 for the Change Order Request and additional funds do not need to be requested from Regeneron at this time; and

**WHEREAS**, the Town Comptroller confirms that the use of contingency is available but will need to monitor any further use;

now, therefore be it

**RESOLVED**, that the Town Board of the Town of East Greenbush affirms that the Change Order Request is an eligible use of funds in accordance with the Regeneron Development Agreement, and stipulates that the Change Order Request costs be funded from the escrow account established pursuant to the aforementioned Development Agreement;

and be it further

**RESOLVED**, that the Town Board, in its continued capacity as Lead Agency under SEQR, finds that the proposed Change Order will not give rise to any significant adverse environmental impacts as it is within the area disturbed by the Tempel Lane project;

and be it further

**RESOLVED**, that the Town Board of the Town of East Greenbush hereby authorizes the Supervisor to enter into the Change Order with Greenman Pedersen, Inc., in an amount not to exceed \$35,480.50 for the inclusion of the proposed addition of 3,800 linear feet of new roadway and the widening of 1,600 linear feet of existing improvements.
