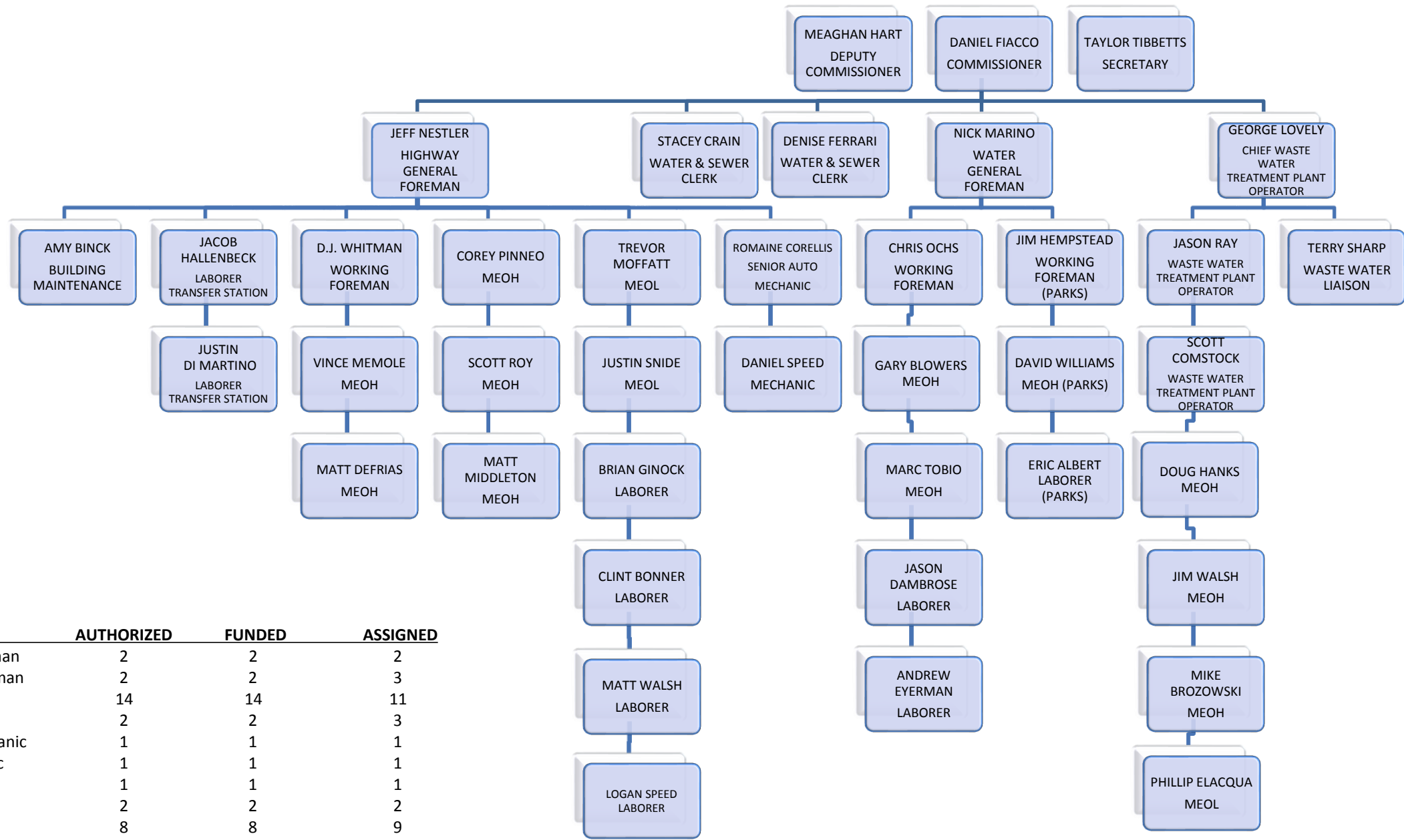

The punch card will be “punched” by the attendant depending on the quantity of refuse brought to the Transfer Station. The number of “punches” is determined at the discretion of the attendant acting within the guidelines established by the Town.

Punch cards allow for disposal as follows:

- 52 (fifty-two) Punch Card allows for disposal of 52 bags.
- 25 (twenty-five) Punch Card allows for disposal of 25 bags.
- Each bag must be 40-gallons or less.
- You **MUST** bring your punch card with you.

#### **NO OVERLOADS WILL BE ACCEPTED ON FRIDAY AND SATURDAY.**

**Transactions at the Transfer Station can only be paid by check. Please make payable to Town of East Greenbush.**
