47-2023 A Resolution Urging the New York State Attorney General and the National Association of Attorneys General to Take Steps to Reduce the Impact of Commercial Tobacco Imagery on Youth

WHEREAS, a study released by the U.S. Food and Drug Administration (FDA) and the U.S. Centers for Disease Control and Prevention (CDC) found that 2.55 million U.S. middle and high school students reported current e-cigarette use in 2022; and

WHEREAS, nearly half (46%) of high schoolers who vape do so nearly daily, putting them on a trajectory for a potential lifetime of nicotine addiction and at increased risk for addiction to other substances; and

WHEREAS, young people are three times more likely to start vaping when exposed to commercial tobacco imagery in popular streaming and TV shows; and

WHEREAS, commercial tobacco imagery remains rampant in the year's most popular shows, movies, and music videos, helping to fuel the e-cigarette epidemic with research showing that commercial tobacco imagery appeared in 60% of 15-24 year-olds' top 15 new shows in 2020; and

WHEREAS, the pervasiveness of onscreen commercial tobacco imagery points to an overall problem with the normalization and glamorization of smoking and vaping in entertainment media and popular culture; and

WHEREAS, researchers say that young people may be imitating the behaviors manifested in commercial tobacco imagery; and

WHEREAS, the detrimental short- and long-term effects of tobacco use in general, and e-cigarettes in particular have been well documented; and

WHEREAS, the Town Board is committed to improving the health and wellness of the community;

now, therefore, be it

RESOLVED, that the Town Board of the Town of East Greenbush joins with Reality Check of New York and a group of high school students from Columbia High School to urge the New York State Attorney General and the National Association of Attorneys General to call for expanded education, outreach, and research efforts to inform the public, parents, directors,

writers and producers of the need for responsible presentation of the realities and danger of tobacco products, including e-cigarettes;

50-2023 A Resolution to Authorize the Chief of Police to Enter into a Five (5) year Agreement for the Use of Subscription Material From Lexipol, LLC by the East Greenbush Police Department

WHEREAS, the East Greenbush Police Department has recognized the need for the outsourcing of administrative services provided by Lexipol, LLC; and

WHEREAS, the utilization of Lexipol, LLC provides the knowledge and assistance required for the implementation of challenging and ever-changing state and federally mandated laws, regulations, court decisions, and evolving best practices; and

WHEREAS, Lexipol, LLC will assist with the development of legally defensible, up to date policies which are the foundation for consistent, safe public safety operations and are key to lowering liability and risk; and

WHEREAS, Lexipol’s daily scenario-based training bulletins are tied to real-world implications and allow officers to apply the agency’s policy content through 2 minute training

exercises, thereby providing the agency with on-going training to fulfill accreditation standards; and

WHEREAS, Lexipol, LLC has provided a contract that offers services to assist the East Greenbush Police Department, which would allow for on-site and remote (telephone and e-mail) consulting services to address the specific needs of the East Greenbush Police Department; and

WHEREAS, the fee for the Lexipol, LLC annual subscription would be \$12,056.90 for 2024, \$12,659.75 for 2025, \$13,292.73 for 2026, \$13,957.37 for 2027 and \$14,655.24 for 2028; which will be paid annually; and

WHEREAS, Fleury Risk Management, who has partnered with Lexipol, LLC has granted the East Greenbush Police Department a \$2,500.00 award to contribute towards the implementation costs of the subscription; and

55-2023 A Resolution Setting a Date and Time for a Public Hearing on a Proposed Local Law Authorizing a Property Tax Exemption for Certain Volunteer Firefighters and Ambulance Workers

WHEREAS, Section 466-a of the Real Property Tax Law, enacted in 2022 by the New York State Legislature, authorizes municipalities to provide for a real property tax exemption for enrolled members of incorporated volunteer fire companies, fire departments, and incorporated voluntary ambulance services; and

WHEREAS, that legislation authorizes municipalities, such as the Town of East Greenbush, to provide for a property tax exemption of up to 10% to those members owning real property in the Town; and

WHEREAS, the State Legislation provides certain parameters for qualifying for such tax exemption; and

WHEREAS, the Town Board believes that adopting a local law under this provision of state law would encourage volunteers for the vital services provided by these organizations; and
