Communications/Announcements/Reports

The Town Clerk, Kimberly Carlock announced that the following departments have handed in their reports and are on file in the Town Clerk's Office.

183-2019 A Resolution Recognizing October as "Domestic Violence Awareness Month" and October 24, 2019 as "East Greenbush Goes Purple Day"

WHEREAS, domestic intimate partner violence is violence or aggression that occurs in a close relationship including current and former spouses and dating partners; and

WHEREAS, data from the CDC's National Intimate Partner and Sexual Violence Survey indicate approximately 1 in 4 women and nearly 1 in 10 men have experienced contact sexual violence, physical violence, and/or stalking by an intimate partner during their lifetime; and

WHEREAS, the 11 million women and 5 million men who reported experiencing this violence also indicated that they first experienced these or other forms of violence by that partner before the age of 18; and

WHEREAS, domestic violence takes many forms, including physical violence, sexual assault, economic control, psychological/emotional abuse, or a combination of more than one of these and violence and can vary in frequency and severity and occurs on a continuum, ranging from one episode to chronic and severe episodes over a period of years; and

WHEREAS, the Town of East Greenbush wishes to support Domestic Violence Awareness Month by raising awareness of the prevalence and dangers of domestic violence between intimate partners;

RESOLVED, to shine light on the subject of domestic violence and potentially reduce the number of acts each year the Town Board recognizes October to be Domestic Violence Awareness Month;

186-2019 A Resolution Authorizing Emergency Repairs to the Water Transmission Line Located on Glenmore Road in the Town of North Greenbush

WHEREAS, in accordance with Town policy and General Municipal Law, all public works expenses in excess of \$10,000 require Town Board approval; and

WHEREAS, on August 23rd at 2:00 p.m., the Commissioner of Public Works was notified of a significant break in the Water Transmission Line that provides water to the Town of East Greenbush and the City of Rensselaer located on Glenmore Road in the Town of North Greenbush; and

WHEREAS, the Commissioner of Public Works assessed the situation with the Water Department Foreman and determined that immediate action was required to restore water service to the Town of East Greenbush and the City of Rensselaer; and

WHEREAS, based on their past experience with this particular section of water transmission line, Wm. J. Keller and Sons Construction Corp. was called in to immediately excavate and stabilize the site so that repairs could be made by the East Greenbush Water Department; and

WHEREAS, the Town Comptroller confirms that the financial impact of this resolution is \$32,887.00 from the Water Fund charge code 8320.4.05, offset by a 43% charge back to the City of Rensselaer for its portion of the bill as determined by the Town Designated Engineer. 195-2019 A Resolution to Direct Certain Mitigation Fees Received in Connection with the Single Family Home Developments at 57 Lona Lane and 59 Lona Lane to the GEIS Water/Sewer Fund

WHEREAS, the Town of East Greenbush received applications for building permits to construct single family residences at 57 Lona Lane and 59 Lona Lane (the "Project"); and

WHEREAS, on March 14, 2007 the Town of East Greenbush Planning Board issued Conditional Approval of the Final Plat for the Birch Lane/Railroad Avenue Major 27-lot Subdivision (aka "Birch Haven Estates" or "the Project"); and

WHEREAS, the Planning Board, as a condition of approval, required that the developer pay fees associated with the project; and

WHEREAS, on March 7, 2007, the Town issued a "Schedule of Outstanding Fees and Payment" for the Project, which schedule included a "Remaining I&I Fee" of \$2,000/lot to be paid prior to obtaining each building permit; and

WHEREAS, Town policy is that land development mitigation fees be paid to the Town in accordance with the Western East Greenbush Generic Environmental Impact Statement ("GEIS") and Local Law No. 5 of the year 2018 in order to mitigate the impact of development in Town, including impacts to the Town's Water/Sewer infrastructure; and

WHEREAS, Local Law No. 5 of the year 2018 created a series of segregated accounts into which land development mitigation fees collected by the Town are to be deposited and among these accounts is the GEIS Water/Sewer account; and

WHEREAS, the Town Comptroller confirms that this resolution has no material impact on the Town's finances;

now, therefore, be it

RESOLVED, that the Town Board finds that the fees assessed in 2007 were collected to mitigate impacts associated with the Town's Water/Sewer infrastructure, that collection of these fees is consistent with the GEIS and the policy outlined in Local Law 5 of 2018, and hereby directs that the \$4,000.00 required in connection with the Project be deposited into the GEIS Water/Sewer account.

196-2019 A Resolution to Accept the Proposed Sketch Plan and Schedule a Public Hearing in Connection with the Amedore Senior Housing Project Major Site Plan (PZD ID 18-02)

WHEREAS, Amedore Homes on behalf of the Applicant, Paul Glaz Jr., has submitted an application for major site plan approval and four area variances to the Town of East Greenbush for construction of the Amedore Senior Housing (aka "Heritage Hills") project near Luther Road, Glaz Road and Newkirk Road in the Town (the "Project"); and

WHEREAS, on September 26, 2018 the Town of East Greenbush Planning Board voted to accept the proposed sketch plan dated April 20, 2018, and last revised September 11. 2018, prepared by Brett Steenburgh, PE, PLLC for the proposed major site plan; and

WHEREAS, on April 18, 2018 (resolution number 81-2018) the Town Board classified the Project as a type 1 action under SEQRA and declared its intent to seek lead agency status in connection with coordinated SEQR review of the Project; and
