#### **Town Board comments**

### **Councilor Tierney:**

- Attended Capital District Conservation Roundtable at Guilderland Public Library. Feature or "show stopping" presentation was by Adam Yagelski and Victoria Manieri from our Natural Resources Inventory work group. They presented on work they had done and everyone was impressed by what we have done in EG over the past two of years.
- Asked by a resident to note on Wed., March 25<sup>th</sup> at 6:30 EG Library will be hosting a discussion about climate crisis with Professor Steven Melbo. Public is invited.

### **Supervisor Conway:**

- Live streaming meeting an important new thing we're doing. If on Facebook and making comments, understand we have no ability to respond. Leave comments if you'd like.
- Participating January 25th at press conference at Rensselaer City Hall re: Dunn Landfill. Speaking on behalf of residents. This had to be regulated better and has to be taken care of better. Mayor of Rensselaer will be there.
- We're in beginning of a transition to new court rules and procedures, and bail reform. Our court has been inundated, with their work almost doubled. Senior clerk was injured in a fall and has been out on worker's compensation. Supervisor acknowledged Stephanie Phillips and Laura Ingelsby who are fighting the good fight and doing a great job under difficult circumstances. Both, as always, have stepped up. Tonight on agenda a part time person will be appointed who will start tomorrow, Jan. 23<sup>rd</sup>, to help, and we hope senior clerk will be back soon as we need her as well.
- During a Public Hearing at last Town Board Meeting, a resident got up at end of session and spoke ill of our Planning Board and made all kinds of charges. The Planning Board for East Greenbush is doing a great job. They are so skilled with so much experience and knowledge. They were not chosen politically. They were chosen for their skills, experience and what they do. They function as a group well. Matt Masten is doing a good job as chair. They have an excellent attorney in Joe Slater. Supervisor continued to defend the Planning Board.

**Open Public Privilege:** NOTE – Each speaker may choose to state name and address prior to addressing the Board and shall be granted the floor for up to five minutes. The Board thanks everyone in attendance for their understanding and also for their desire to actively participate in the decision making process. All speakers must conduct themselves in a civil manner. Personal attacks will not be tolerated.

#### **Public comment**

Dave, a resident, commented re: Regeneron and how much money we're not getting in taxes. Mentioned IDA benefits from county should be looked at closely and somewhat mitigated and Board agreed. He presented spreadsheet to Supervisor and Town Board regarding six (6) Regeneron properties. Resident discussed other assessments and tax comparisons.

Supervisor addressed recent tax certiorari cases with Wal-Mart and Target and stated Regeneron gets pilot up front. Town Board does not know when someone applies for a pilot. We get notice for Public Hearing and at that point the deal is pretty much done. Regeneron is a world class corporation, spending money in town directly. Their employees are providing ancillary benefits and a lot of direct benefits with some buying houses now. It's a great company and they do business the right way. Their work with the town has been generous. I'm very proud to have Regeneron in this town and to an effect, build this town around Regeneron. The pilots are a problem, but if anyone is a fair candidate for a pilot it's Regeneron because the IDA was set up to create jobs and to create incentives for the job creation. When they're all done they'll have 4,000 employees in a town of 16,000 people. It has brought a lot of benefits to the town and has raised a whole host of development challenges, but they're aware of it and they work with us.

**Councilor Matters** – discussed one purpose of having pilots is the long term retention of a business. Not within East Greenbush, but we've had localities in the capital district that have experienced businesses after the pilot dries up they leave town. Like the Supervisor mentioned, Regeneron is being looked at as being one of those long term businesses and that's probably where most of the value is to the Town of East Greenbush.

**Councilor Tierney** – circle of peers that I have and Town Clerk, Mrs. Pangburn has too, with younger people looking for jobs and looking for careers in town there is hope that after college or their education that they remain here and that they can work here. The peer group that my children have and their parents are really happy about those opportunities.

**Resident** – Trust but verify. Asked if board they knew the metrics. Super IDA forgiven between 8% and 10% of our tax base.

### Town Board Workshop: Creation of a Conservation Advisory Council (CAC)

Councilor Tierney – attended roundtable with Adam Yagelski 2 years ago; now in stage of forming a CAC. Developed Natural Resources Inventory to start. Once completed we need to keep it alive. We now need to develop CAC to advise planning decisions and the Board of what our resources are. Excellent work group of volunteers did inventory and put together letter with draft laws and volunteer announcement. Note our strengths and where we need to make modifications to meet our needs.

**Supervisor Conway** – Excellent submission. Victoria's letter was excellent. Like how climate change was mentioned. Receiving a lot of inquiries about this and how we're addressing environmental issues. Something Councilor Tierney has been pushing for four years now. We've been on this track and we've done a lot of work with this.

**Town Board and Dave Gruenberg** – further discussed Conservation Advisory Council (CAC) after having received and reviewed letter. Membership and appointments, Officers Meetings and Committees, budget, Powers and Duties of the Council, resources/library were all further discussed. Recommend research and inform (not report) on standing issues. Town Board to balance these things. Provide format instead of formal structure. State law is very specific. Recommended some changes and consideration of some issues. Town Board will come up with new draft for NRI group to review. Supervisor extended thanks to Victoria. At February Board meeting we'll schedule Public Hearing, probably for March. Board is very much in favor of this.

## 05-2020 A Resolution Celebrating the 165<sup>th</sup> Anniversary of the Town of East Greenbush

**WHEREAS**, the first settlement of the land now known as East Greenbush was made by tenants under patroon Kiliaen van Rensselaer circa 1630 and was part of the Manor of Rensselaerswych and Albany and Columbia Counties prior to Rensselaer County's creation in 1791; and

**WHEREAS**, the Town of Greenbush was formed from Rensselaerswyck on April 10, 1792. The Village/Town of Greenbush was mapped out in 1810 and incorporated in 1815. A part of West Sand Lake was separated in 1812. The Towns of Clinton and North Greenbush separated in 1855, leaving the present Town of East Greenbush, the corporate limits of which were defined by legislation passed on April 9, 1852; and

**WHEREAS**, the Town of East Greenbush was formally established in 1855 as Clinton, and its first municipal meeting was held on April 3, 1855 in the William R. DeFreest Hotel (now the Your Day Your Way bridal shop); and

**WHEREAS**, Clinton was renamed East Greenbush in 1858, the name originating in the Dutch words *groen bosch* (literal translation 'green forest'), referring to the pine woods that originally covered the land;

now, therefore be it

## 06-2020 A Resolution to Recognize February as AFRICAN AMERICAN HISTORY MONTH in the Town of East Greenbush

**WHEREAS**, in 1926 the Association for the Study of Negro Life and History announced that the second week of February would be 'Negro History Week' because it coincided with the birthdays of Abraham Lincoln (February 12) and Frederick Douglass (February 14); and

**WHEREAS**, with the Civil Rights movement and a growing awareness of black identity fostered by the work of our Civil Rights pioneers; and

**WHEREAS**, from these origins the celebration of the contributions of African Americans to American society increased on an annual basis leading the Black United Students at Kent State University to propose in 1969 that the celebration be expanded to encompass the entire month of February, a proposal that was implemented at Kent State in 1970; and

**WHEREAS**, within six years Black History Month was being celebrated in educational institutions and community centers all over the country; and

**WHEREAS**, President Gerald Ford officially recognized Black History Month during the celebration of the United States Bicentennial in 1976 urging his fellow Americans to "seize the opportunity to honor the too-often neglected accomplishments of black Americans in every area of endeavor throughout our history;" and

**WHEREAS**, the month-long celebration, now known as African American History Month, has been officially recognized at the Federal, State and Local levels of government; and

**WHEREAS**, the contributions of African Americans from all walks of life and their endeavors to learn, thrive and contribute throughout history makes it imperative that we recognize the unforgettable marks made by African American artists, scientists, educators, business people, influential thinkers, members of the faith community, athletes, and political and governmental leaders who have contributed so much to the greatness of America;
