Communications/Announcements/Reports

Councilor DiMartino announced that to The Town Board and the Community Recreation Department will be holding a Town Hall style meeting to improve programming for the Town's Seniors on November 18th at 11:00 am in the Community room in town Hall. All seniors and family members, including members from our mahjong, bocce, and domino groups are welcome to attend and offer suggestions.

Councilor DiMartino also announced that DPW will be picking up appliances from December 5th until the 9th. Please call the DPW to make an appointment for pick up at 477-6103.

Councilor DiMartino announced in detail the December activities from the Community and Recreation web site. Some of these activities that she announced were include the Senior paint and punch, Gingerbread house competition, and the Tree Lighting ceremony. You can find this information for these events and other events on the Community and Recreation department's web site, or call Jessica Lansing at 477-4194.

Councilor DiMartino stated that Thanksgiving is not only a time to give thanks for what you have and who you have, it is also a time to be grateful for what you are going to have. She wished everyone a happy and safe Thanksgiving.

Councilor Matters- reminded everyone that Veterans Day was November 11th. She explained that there is never a time when our veterans who sacrificed everything in the line of duty to keep us safe are out of our prayers, and thanked them for their service.

She explained that Thanksgiving is her favorite time of year, and that it is a time to take stock of our many blessings. She wished everyone a happy and safe Thanksgiving, filled with peace love and peace.

Councilor Matters announced that NY Market and Specialty foods has opened on 6 Columbia Turnpike. It is focused on locally sourced food products from this state as well as international groceries. She reminded everyone to shop locally.

Councilor Grant wished everyone a Happy Thanksgiving, wished them safe travels and hopes everyone enjoys their time with family and friends.

Councilor Tierney announced the opening of the New Beginnings consignment shop along with the Recovery room. She stated that she is very happy that we have some new business in town. She also reminded everyone to shop locally Thanksgiving weekend.

Supervisor Conway announced that the gas tanks were removed at the town garage today.(November 16th) The town had been under consent order because of contamination of the soil there. DEC came in today and found that the soil is not contaminated. He joked that he would like a refund.

He also stated that we got the final report on the Hampton Manor Water Tanks. The small tank will have to be replaced, the larger one will need serious work. He explained that the Town has formed a work committee to cost out our options, and then he will call another meeting of the Hampton Manor residents to discuss options.

Supervisor Conway also stated that the auditors are in Town Hall and should have their report by December.

Resolutions and Proposals by Town Board Members:

Mary B. stated that she has been thinking about Councilors Matters comments on the budget and wanted the Town Board to consider them.

The Supervisor explained that they did the Budget in hopes that there would not be a tax increase. The things that would have been taken out to have no tax increase would be new Accounting software, audits, not treating the odor at the waste water treatment plant, and not adding anything to the road paving budget. The Supervisor explained that they had to make a call as to whether these things we were willing to pay for. He stated that things have been let go for way to long and it is the reason the Town is in the shape that it is in. He did not want to overburden the tax payers, and tried to keep the raise as low as possible. Supervisor Conway went on to explain the budget and overtime.

Councilor Matters stated that if we reduced overtime by 25% we would not need a tax increase. She went on to explain her stance on a slower more conservative approach.

Pete S. – Thanked Jessica Lansing for organizing the food drive for Concerns U. He questioned why we were not waiting for the point of sale machine till 2017.

220-2016 A Resolution Approving the Adoption of the Annual Budget for Fiscal Year 2017

WHEREAS, pursuant to New York Town Law § 106, subd. 2, the East Greenbush Town Supervisor duly filed a Tentative Budget and budget message in the Office of the Town Clerk on September 29, 2016 (referred to hereinafter as the "Tentative Budget"); and

WHEREAS, the Tentative Budget provided for a 0.90% increase in the Town's Real Property Tax Levy for fiscal year 2017; and

WHEREAS, pursuant to New York Town Law § 106, subd. 4, the East Greenbush Town Board, at a special meeting held on October 24, 2016 and with dissenting votes cast by Councilor Matters, duly approved a preliminary budget which was duly filed in the office of the Town Clerk on October 24, 2016 (referred to hereinafter as the "Preliminary Budget"); and

WHEREAS, the Preliminary Budget provided for, among other things, a tax increase of 1.47% in the Town's Real Property Tax Levy for fiscal year 2017, along with a spending increase; and

WHEREAS, pursuant to New York Town Law § 108, the East Greenbush Town Board duly conducted a public hearing on November 3, 2016 on the Preliminary Budget; and

WHEREAS, the Town Comptroller confirms that this resolution will not have a material impact on the Town's finances;

now, therefore, be it

RESOLVED, that, pursuant to New York Town Law § 109, subd. 1, the Preliminary Budget be, and the same hereby is, duly adopted as the Annual Budget for fiscal year 2017 (referred to hereinafter as the "Adopted Budget");

and be it further

RESOLVED, that the Town Clerk shall cause a copy of the Adopted Budget to be duly filed in her office, forthwith, following receipt thereof from the Comptroller; and be it further

RESOLVED, that, pursuant to New York Town Law § 109, subd. 3, the supervisor, Director of Finance, Comptroller, Receiver of Taxes, and Assessor take all respective action required and/or appropriate relative to the implementation of the Adopted Budget.

The foregoing resolution was duly moved by Supervisor Conway and seconded by Councilor Grant and brought to a vote resulting as follows:

Councilor Tierney thanked Supervisor Conway for understanding this process and understand this budget because this is her first time going through it. She explained that he was very patient and answered all her questions. George Phillips was also extremely helpful with this process. He answered all of her questions accurately and thoroughly, and he is a real asset in this process. Councilor Tierney stated that she learned a lot during this process. **Councilor Matters** stated that she can't support the 2017 budget because of the tax increase. She stated that if anyone wants more details about why she can't support this budget she left some paper work on the table. She explained that this does not mean that she does not support Jack, Tina and Tom. She went on to explain her thoughts on that, and also that she feels it is good for the Board to have opposing views.

Councilor DiMartino discussed wanting to keep it below 1% and when she found out the County was working on keeping their budget under below .08% she might change her mind.

Councilor Grant stated that Supervisor Conway and George were very receptive and available while working on the budget. They did not agree on everything, but there was a lot of healthy discussion. He stated that it is very important to him to keep taxes low. He noted that the budget is still substantially under the tax cap. Councilor Grant stated that this is a well thought out budget that respects the work force, and also respects the tax payers in the town. HE also stated that the residents have to have an expectation that things in the town will get done. There are increases in equipment, salaries and a plan to get things done. He is sorry that there is a slight tax increase but it takes money to get things done. He also stated that it was not done in the past two years.

Supervisor Conway stated that he is very proud of this budget. He explained that in the process of dissecting this budget he learned how to do his job. He now understands where we are and where we are going. Supervisor Conway explained that he played this process by the book. He explained that with the help of the director of finance and the Town Comptroller playing their rolls, and himself acting comprehensively as the Chief Finance Officer for the Town they made their way through this budget process. He then brought the Town Board into the process. It was a collaborative process and he thinks they did it correctly.

Supervisor Conway stated that the number one job is to deliver essential services. He feels our delivery system has been starved. HE went on to explain that DPW and the Police Department have been vastly understaffed. The equipment has been neglected and is dangerous. Town hall has been neglected also. HE went on to explain that things are old and that they just don't work. He explained that there is no heat as of right now in the Police Department. The way that the Town does its business has been neglected. He stated that that stops now. It stops with this Board and this Supervisor. The Town will be properly cared for.

He stated that this is a cost effective and fair budget. This budget we are paying back \$683,000.00 *in inter-fund borrowing. He does believe in this budget and he is very proud of it.*

WHEREAS, CDPHP and Amsure held an informational meeting on November 15, 2016 for employees to break down the differences in policies so that employees are able to make the best selection for their family's health care needs; and

WHEREAS, the EPO 120 Copayment Plan is marginally less expensive than the CDPHP EPO 100 Copayment Plan, and offers employees a comparable plan without the 20% copayment of office administered medications; and

WHEREAS, the Town Comptroller confirms that this resolution will not have a material impact on the Town's finances;

LOCAL LAW #4 OF THE YEAR 2016 OF THE TOWN OF EAST GREENBUSH

LOCAL LAW ADOPTING AND RATIFYING THE LAND SUBDIVISION REGULATIONS OF THE PLANNING BOARD OF THE TOWN OF EAST GREENBUSH, AND MAKING AMENDMENTS THERETO

Be it enacted by the Town Board of the Town of East Greenbush as follows:

Section 1 –

The Land Subdivision Regulations, as adopted by the Planning Board on May 28, 1986 and approved by the Town Board on June 4, 1986, and as amended by resolution of the Town Board on April 22, 1987, and by Local Law on August 11, 1999, are hereby

adopted and confirmed by the Town Board of the Town of East Greenbush, pursuant to Section 271(13) of the Town Law.

Section 2 –

Said Land Subdivision Regulations are hereby amended, by adding to Article VI, Section 4 (E) (2) the following paragraph:

"The Secretary of the Planning Board shall provide notice of any public hearing regarding a major subdivision, including data regarding the substance of the application, to the owners of all property within two hundred (200) feet of the land involved in such application. Notice shall be provided by either certified or registered mail at least seven (7) calendar days prior to the hearing with costs to be borne by the applicant."

Section 3 –

This local law shall take effect immediately.
