### A Resolution in Support of Raising Awareness of Sarcoidosis and Declaring April Sarcoidosis Awareness Month in the Town of East Greenbush

WHEREAS, Sarcoidosis is a disease which can affect multiple organs in the body; and WHEREAS, Sarcoidosis is an autoimmune disease associated with an abnormal immune response, but the trigger for the abnormal response is unknown; and

**WHEREAS**, Sarcoidosis most commonly targets the lungs and lymph nodes, but the disease can affect other organs too, such as the skin, eyes, liver, salivary glands, sinuses, kidneys, heart, muscles, bones, the brain and nervous system; and

**WHEREAS**, the symptoms of Sarcoidosis depends on the organ affected, but generally speaking symptoms will include fever, weight loss, night sweats and an overall feeling of malaise as well as persistent cough, enlarged lymph nodes, shortness of breath, headaches, visual problems, joint pain, eye pain and sinusitis; and

WHEREAS, while there is no cure for Sarcoidosis, there are treatment options; and

**WHEREAS**, to further the public's awareness of Sarcoidosis and its effects on those diagnosed with this autoimmune disease, the Town of East Greenbush wishes to encourage Sarcoidosis awareness among residents of the Town of East Greenbush;

### A Resolution to Purchase a Supply of Duty Ammunition for the East Greenbush Police Department for the Year 2022

**WHEREAS**, the Town Board intends to provide members of the Town Police Department and EGPD SSRT members with sufficient duty ammunition for their respective biannual and bi-weekly training in order to maintain their certifications, and to carry on duty; and

**WHEREAS**, the current supply of ammunition nationwide is depleted and the firearms instructors have been advised by the distributors that there may not be sufficient ammunition necessary for the police department members to qualify for the 2022 upcoming spring and fall range, nor for the SSRT members to continue to train throughout 2022, and have a sufficient supply to carry on duty if the department supply isn't secured in a timely fashion; and

**WHEREAS**, the police firearms instructors and the Chief of Police have recommended to replenish the 9mm and .223 caliber duty ammunition; and

**WHEREAS**, the Town Comptroller has determined that this resolution will not have a material impact on the Town's finances;

**WHEREAS**, the County of Rensselaer and the Town of East Greenbush share a mutual interest in enforcing existing Handicap Parking laws and in deterring the use and abuse of designated Handicap Parking locations; and

**WHEREAS**, this goal can be accomplished by increasing public awareness by maintaining a high visibility in the law enforcement area, and by increasing enforcement to deter the motoring public from disobeying the Handicap Parking laws; and

**WHEREAS**, the County will grant an amount not-to-exceed \$1,875.00 to fund Handicap Parking enforcement, which will be reimbursed in a lump sum at the termination of the patrols; and

**WHEREAS**, the Town of East Greenbush agrees that special Handicap Parking patrols will be implemented by the Town throughout the calendar year and such patrols will be assigned to road patrols for vehicle and traffic violations of handicap parking offenses only. Emergency situations may be answered to provide initial backup only; and

**WHEREAS**, the Town of East Greenbush acknowledges and agrees that the services to be provided pursuant to the terms of this agreement are provided as an independent contractor and not as an agent or as employees of Rensselaer County, and agrees to indemnify and hold harmless the County of Rensselaer from and against any and all claims or causes of action; and

**WHEREAS**, the Town Comptroller confirms that this resolution will not have a material impact on the Town's finances;

**WHEREAS**, the County of Rensselaer and the Town of East Greenbush share a mutual interest in enforcing existing DWI laws and in decreasing the number of alcohol-related motor vehicle accidents through special counter-measure enforcement programs; and

**WHEREAS**, this goal can be accomplished by increasing public awareness of the dangers of impaired driving by maintaining high visibility in the law enforcement area, by increasing enforcement to deter the motoring public from driving while impaired, and by enforcing alcohol laws as they relate to minors; and

**WHEREAS**, the County will grant an amount not-to-exceed \$4,500.00 to fund STOP-DWI Enforcement Crackdown Patrols, which will be reimbursed in a lump sum at the termination of the patrols; and

**WHEREAS**, the Town of East Greenbush agrees that special DWI patrols and underage drinking enforcement will be implemented by the Town throughout the calendar year with such patrols staffed by officers who have completed basic training and have experience on road patrols, in particular apprehending and charging impaired drivers; and

WHEREAS, the Town of East Greenbush acknowledges and agrees that the services to be provided pursuant to the terms of this agreement are provided as an independent contractor and not as an agent or as employees of Rensselaer County, and agrees to indemnify and hold harmless the County of Rensselaer from and against any and all claims or causes of action; and

**WHEREAS**, a settlement proposal resolving tax certiorari litigation was recommended by the Vincelette Law Firm, special counsel to the Town of East Greenbush, and reviewed by the East Greenbush Town Board at its regular monthly meeting; and

**WHEREAS**, such a proposed settlement would present the parties with an expeditious and economic alternative to further litigation so as to resolve issues between the parties; and

# 91-2021 A Resolution Adopting Local Law Number 3 of 2021 to Provide for Certain Amendments Relating to the Senior Citizen Real Property Tax Exemption in the Town of East Greenbush

**WHEREAS,** Local Law No. 3 of 1982 held that the computation of income eligibility for the Town's senior citizen real property tax exemption would not include an offset for certain medical and prescription drugs costs; and

**WHEREAS**, Local Law No. 1 of 2004 set the maximum annual income eligibility for the senior exemption at \$32,400.00; and

**WHEREAS,** the Town Board of the Town of East Greenbush wishes to modify certain provisions of its law relating to the granting of senior citizen exemptions for real property taxes imposed by the Town; and

**WHEREAS**, the Town Board also wishes to allow applicants for such exemption to deduct from their income, for the purposes of such application, all medical and prescription drugs expenses actually paid, which were not reimbursed or paid for by insurance; and

**WHEREAS**, the Town wishes to amend Local Law No.3 of 1982 by providing an offset to income of medical and prescription drug costs that were actually paid and not reimbursed or paid for by insurance; and

**WHEREAS,** the Town Board wishes to modify Local Law No. 1 of 2004 by making the senior citizen partial exemption available to seniors earning up to \$37,400.00, to conform to the current maximum under State law; and

**WHEREAS**, a public hearing was held on April 14, 2021 and everyone who wished to be heard was heard; and

**WHEREAS,** the Town Comptroller confirms that this resolution will not have a material impact on the Town's finances;

now, therefore, be it

**RESOLVED**, that the Town Board of the Town of East Greenbush hereby adopts Local Law No. 3 of the year 2021 to provide for certain amendments relating to the Senior Citizen Property Tax Exemption as described herein.

- o Post-termination Reimbursement: For the Plan Year(s) starting in 2020 and 2021, notwithstanding any other provision of the Plan to the contrary, shall post-

#### • Dependent Care Assistance Program (DCAP)

- Access to Prior Year Balances: For the Play Year(s) starting in 2020 and 2021, notwithstanding any other provision of the Plan to the contrary, the DCAP shall permit an extended Carryover of full unused balance.
- Extended Dependent Eligibility: For certain DCAP participants as defined below, a qualifying individual shall mean; a dependent of the taxpayer as defined in Code § 152 (a) (1) (i.e., a qualifying child) who has not attained age 14. This change to the definition of qualifying individual applies solely to a Dependent Care FSA participant who has one or more dependents who attain age 13 during the last plan year whose enrollment period ended on or before January 31, 2020 (the "2020 plan year").
