# 298-2022 A Resolution to Approve the Procurement of Personal Services with Integra HR, LLC for the Purpose of Providing Ethics Training to Town Employees

**WHEREAS**, in accordance with subdivision a of section 21 of the East Greenbush Town Code of Ethics (referred to hereinafter as the "Ethics Code"), as enacted pursuant to East Greenbush Local Law No. 3 of 2016, all town employees are required to attend a training seminar on the Ethics Code; and

**WHEREAS**, the Town Board recognizes that, given the unique nature of the subject matter covered by ethics training, such training will be best received by town employees if it is

conducted by a professional trainer who is external to the town and who possesses the skillsets to do so competently and effectively; and

WHEREAS, in preparation for such ethics training and as a prelude to the procurement of ethics-related training services (referred to hereinafter as the "Services"), a preliminary training module was composed in PowerPoint by Councilor Tierney in order to better and more efficiently facilitate such procurement and to thereby save the town the additional expense of such preparation by the Services provider; and

**WHEREAS**, following a procurement search for a Services provider, including Public Sector HR Consultants, LLC which has previously provided HR-related services to the town but indicated that it was unable to provide the Services, the town identified Integra HR, LLC (referred to hereinafter as "Integra"), a local, women-owned business enterprise which is ready, willing, and most able to provide the Services in early 2023; and

**WHEREAS**, Integra submitted to the supervisor an engagement proposal dated November 22, 2022, which has been reviewed by the members of the Town Board, that was deemed to be substantively responsive to the description of Services and a good value to the town, including a fee not to exceed \$6,400.00; and

**WHEREAS**, the Town Comptroller confirms that this purchase is budgeted in 2023 for \$5,000 (122204.01.04 Supervisor CE \$2,550, 51104.02.04 Highway General Repair CE \$950, 83104.05.04 Water Admin CE \$800, 81104.07.04 Sewer Admin CE \$700; and will have an immaterial 2023 budget impact on the General Fund Balance A917 of \$1,400;

WHEREAS, in order to effect changes a Local Law must be drafted and a Public Hearing held but this hearing is preliminary to that process. We want to hear from residents before we craft the Local Law and will hold a formal Public Hearing after the Local Law has been drafted: and

WHEREAS, the Town Comptroller confirms that this resolution will not have a material impact on the Town's finances;

now, therefore, be it

Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the Municipality's/Sponsor's first instance funding of project costs and permanent funding of the local share and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible,

**RESOLVED**, that a Certified Copy of this resolution be filed with the New York State Commissioner of Transportation of the State of New York by attaching it to any necessary Agreement in connection with the Project between the Town of East Greenbush and the State of New York;

and it is further
