

## 224-2017 A Resolution Appointing Adam Yagelski to the Position of Director of Planning and Zoning

WHEREAS, the Town of East Greenbush faces a complex array of planning and zoning issues; and

**WHEREAS**, the essential duties and responsibilities of the Director of Planning and Zoning include the following:

- Develop and maintain the annual budget of the Department of Planning and Zoning;
- Facilitate the work of the Planning and Zoning Boards, including providing technical assistance and attending meetings;
- Develop a plan for the revitalization of Columbia Turnpike;
- Assist developers to understand the Town's review process;
- Conduct coordinated SEQRA reviews;
- Calculate development and mitigation fees and prepare fee letters;

- Interpret the rules and regulations of Planned Development Districts to ensure compliance with the Town's Comprehensive Plan and Town Code;
- Oversee the MS4 program and prepare annual report; and
- Draft resolutions for Town Board meetings on planning and zoning issues; and

**WHEREAS**, the Town Board posted an advertisement seeking a qualified applicant for the position of Director of Planning and Zoning in trade publications and the official Town newspaper and advertised on the Town's website; and

WHEREAS, applications were reviewed and three candidates interviewed; and

**WHEREAS**, Adam Yagelski met all of the qualifications and participated in two interviews with Town staff and members of the Town Board; and

**WHEREAS**, the Town Comptroller confirms that this position was included in both the 2017 and 2018 budget funding of account 80201.01.01 Planning PS;

now, therefore, be it

**RESOLVED**, that Adam Yagelski is hereby appointed Director of Planning and Zoning for the Town of East Greenbush at an annual salary of \$65,000.00;

and be it further

**RESOLVED**, that this appointment shall take effect immediately.

225-2017 A Resolution Authorizing the Supervisor to Sign a Settlement Agreement By and Among the Town of East Greenbush and the East Greenbush Police Officers Union, Local 1951, of Security and Law Enforcement Employees, Council 82, American Federation of State, County and Municipal Employees, AFL-CIO and James Cook

**WHEREAS**, the Collective Bargaining Agreement (hereafter 'CBA') contains a provision outlining the parties' agreed-upon procedure (207-C Procedure) with respect to the granting of, and administration of, benefits to Association members, pursuant to New York State Municipal Law; and

**WHEREAS**, Officer Cook was granted 207-C benefits as a result of a work-related injury incurred on or about January 10, 2009; and

**WHEREAS**, as a result of this injury, the Officer has undergone various procedures and treatments for which the Town has reimbursed the Officer for expenses incurred; and

**WHEREAS**, the Town has denied payment/reimbursement for certain expenditures for which the Officer failed to provide the necessary medical records/releases to allow the Town to determine if they were related to the Officer's injury; and

**WHEREAS**, the Association filed a grievance dated October 6, 2014 which alleged that the Town violated Article 7.10.1 of the CBA "by failing to pay for the Officer's medical treatments necessitated by the injury/illness sustained in the performance of his duties"; and

**WHEREAS**, the Town denied the grievance and hearings were held in front of an arbitrator on May 19, 2017 and November 16, 2017; and

WHEREAS, a settlement agreement was reached among the parties; and

**WHEREAS**, the Town Comptroller has confirmed that this resolution will have a material negative impact on Town finances of \$11,239.56 and will be funded by the following budgetary transfer:
